### NDCDE Needs Your Help: Survey Participation Request

As CDE continues to prepare for fall, we are requesting the help of North Dakota public and private schools with estimating how many additional adjuncts we'll need to support two new laws, which are summarized below.

**Cybersecurity and computer science (HB 1398):** CDE sent a preliminary needs assessment survey this spring to determine which districts need our help responding to these new curricular requirements. We now need your assistance **finalizing** cybersecurity and computer science enrollment numbers. As a reminder, for **this school year**, under HB 1398, all approved schools must do the following:

- By August 2023: Provide computer science and cybersecurity instruction to elementary and middle school students and make available one unit of computer science or cybersecurity at the high school level (computer science can be offered as a math course; computer science and cybersecurity can be offered as science courses)

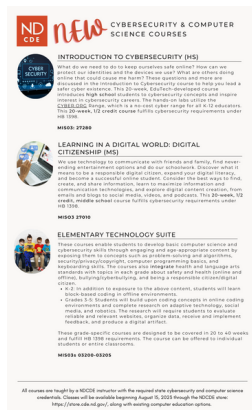

**Virtual school choice:** HB 1376 takes effect on **August 1, 2023**. This bill expands virtual school choice options for students through the following:

- A provision is added requiring school districts to pay the cost of NDCDE tuition for enrolled students
- Removes the stipulation that a school district/administrator can deny a student's enrollment in NDCDE courses
- Allows a student to open enroll in any approved virtual school (see NDCC 15.1-06-06 for approval criteria), including those run by another North Dakota school district

NDCDE is committed to maintaining its strong partnership with state school districts once this law takes effect. It is exploring how it can adjust enrollment and virtual classroom policies and procedures to maintain communication, collaboration, and transparency with our local school partners. We also want to ensure adequate instructional staffing to support enrollment growth under this law.
